

ALTRONIC PRODUCT WARRANTY FORM W-AS 10-09

WARRANTY

The Altronic Ignition Systems, Engine Control Products and Digital Instruments and Parts are warranted against failure in normal usage, when installed in accordance with the applicable Altronic installation instructions, due to defects in workmanship or materials. The period of warranty coverage is as follows:

DC-POWERED DIGITAL IGNITION PRODUCTS, FUEL CONTROL PRODUCTS AND DIGITAL INSTRUMENTS — Two (2) years from date of sale to the first end user or thirty-six (36) months from date of shipment from the factory, whichever occurs first.

OTHER IGNITION UNITS AND COMPONENTS — One (1) year from date of sale to the first end user or twenty-four (24) months from date of shipment from the factory, whichever occurs first.

SPARK PLUGS, SPARK PLUG LEADS, AND ENGINE EXHAUST/OXYGEN SENSORS — these parts are warranted to be free of defects in manufacturing or materials as sold. These do not carry a service time warranty due to the uncertain nature of the application in which they are placed, and their normal operating service life may vary considerably.

Damage due to physical abuse, exposure to excess temperature or moisture conditions, foreign debris introduced into the device by any means, or misapplication is not covered by this Warranty. No product will be covered by this Warranty if its serial number has been deleted or altered in any way.

This Warranty does not apply to the cost of installation, cost of removal, consequential or concurrent damages. Altronic's sole obligation under this Warranty shall be, at its option, the free repair, free replacement or a credit refund for the purchase price of any product or part which is found to be defective upon the prepaid return of said component to Altronic, Inc. Components must be returned within 90 days of the occurrence of the defect and must be accompanied by a completed Altronic, Inc. warranty form.

This Warranty is in lieu of all other warranties expressed or implied.

WARRANTY CLAIM PROCEDURES

1. All warranty claims for labor and materials must be submitted through an authorized Altronic Central Distributor. Warranty claims must be accompanied by a completed and signed Altronic warranty form WF-AS. Incomplete warranty forms will delay processing of the claim and will cause forfeiture of the processing fee for that claim.
2. Each warranty claim must be limited to one Altronic system or part.
3. Materials submitted for warranty consideration must be returned prepaid to:

Do not mix warranty materials with other types of items (exchange materials, repairs, etc.) in the same shipping carton. Clearly mark the outside of the carton with the word "WARRANTY" or the letters "WC".

4. Distribution of the Warranty form WF-AS copies is as follows:

Pink: Retained by authorized Dealer; Dealer to forward blue and white copies to Authorized Central Distributor.

Blue: Retained by authorized Central Distributor.

White: Return to Altronic factory with materials submitted for warranty consideration.
